There is no fee for vending or exhibiting at the Troost Ave. Festival on April 28, 2012 we do however encourage vendors and exhibitors to donate to the Festival for the opportunity to get the word out about your projects and business. If you need us to provide table and chairs the rental cost is \$10 per setup (our costs) and must be arranged for prior to the Festival. Paypal Donate button on <http://www.troostvillage.org> .

All vendors, exhibitors and volunteers must sign the Vendor, Exhibitor, & Volunteer Release of Liability, Waiver and Indemnity form. Form is available online at <http://www.troostvillage.org>.

Vendor/Exhibitor space is not strictly assigned except for the businesses that are active on the 3100 block of Troost - they reserve the sidewalk space in front of their store. The lot at the sw corner of 31st & Troost is reserved for Festival assignments, and we need to keep the center of the street clear until after the open drill team performance. Food Vendors with generators are asked to set up halfway down the street from the stage. Please check with occupied store proprietors for their set up preferences, otherwise first come, first served.

SET-UP can begin on the 3100 block of Troost Ave at 8 am. Vendors are not required to stay until 10 pm, if you need to leave early bring a dolly or cart to transport your exhibit to your car. The street is blocked to traffic and parking is available on surrounding streets.

ATTENTION FOOD VENDORS - If you do not have a food vendor licence from the KCMO Health Dept, you MUST make application for a **Temporary Event Food Permit** (816/513-6315), their forms are available online at <http://www.kcmo.org/health.nsf/web/foodtemps> or you can pick up forms at a Troost Festival planning meeting (Thurs, 7:30 pm, 3101 Troost). You are ultimately responsible for meeting all food safety requirements. You must be set up by 11 am for the on-site inspection by the Health Dept. - Food Vendors need to provide their own power - we will not be able to provide power.

Hints for exhibiting on Troost -

- 1- There is very little shade opportunity on Troost - it is tempting to set up on the east side of the street in the morning but you will then be in the afternoon sun. Dress in layers, bring sunscreen, hats!
- 2- Troost Ave is notoriously windy - come prepared with weights, ropes, etc.

THERE IS NO ALTERNATE DATE FOR THE FESTIVAL, invasion sunshine!!

2012 Troost Ave, Festival Vendor, Exhibitor & Volunteer Release of Liability, Waiver and Indemnity

THIS IS A LEGALLY BINDING RELEASE, WAIVER AND INDEMNIFICATION AGREEMENT (this "Agreement"). Please read it carefully, fill in all blanks and initial each paragraph before signing.

____ I, _____ hereby affirm that I have read this document in its entirety. By my signature below and by initialing each paragraph, I agree to each and every term and condition of this document. I have signed this release of my own free will and I have not been coerced in any way to sign this release.

____ I hereby certify that I am over 18 years of age and competent to execute this release.

____ I hereby certify that I am not over 18 years of age. If this box is checked, you must have your parent or legal guardian counter sign this release in the space provided on page 3 before you will be permitted to participate in the Festival.

Released Parties

____ 2. "Released Parties" refers to Troost Ave. Festival, or Troost Festival, and any of its affiliates, agents, employees, independent contractors, officers, directors, members, managers, volunteers, insurers, attorneys, heirs, predecessors, successors, administrators, assigns and any other person or entity in any way associated with the Troost Ave. Festival.
Festival

____ 3. "Festival" means the 2012 Troost Ave. Festival to be held April 28th, 2012, at 31st and Troost, Kansas City, Missouri, including all preparation and construction for the Festival, whether before or after the Festival opens or closes, which are in any manner related to or part of the Festival.

Release and Consideration

____ 4. AS LAWFUL CONSIDERATION FOR MY BEING ALLOWED TO PARTICIPATE IN THE FESTIVAL.

____ (a) I, on behalf of myself (and on behalf of my executors, administrators, heirs, next of kin, successors, assign, and anyone claiming any interest through them), hereby KNOWINGLY, INTENTIONALLY AND VOLUNTARILY ASSUME ALL OF THE RISKS AND LIABILITY ARISING FROM BY PARTICIPATION IN THE FESTIVAL AND HEREBY WAIVE, RELEASE, INDEMNIFY AND AGREE TO HOLD HARMLESS THE RELEASED PARTIES FROM ANY AND ALL ACTIONS, SUITS, CLAIMS, DAMAGES AND LIABILITY (INCLUDING, BUT NOT LIMITED TO, ATTORNEYS' FEES AND COSTS), that I, my family, heirs, successors, assigns and anyone claiming any interest through me, MAY HAVE FOR ANY INJURY, DEATH, HARM OR PROPERTY DAMAGE CAUSED TO ME OR BY ME OR BY OTHERS ACTING ON MY BEHALF, ARISING OUT OF MY PARTICIPATION IN THE FESTIVAL. I acknowledge and agree that the liability I am hereby assuming may arise from negligence or carelessness of the part of the Released Parties.

____ (b) I personally assume all risks, whether foreseen or unforeseen, in connection with my participation in the Festival, for any harm, injury, or damage that may befall me while I participate in the Festival, including the risk of negligence or any party or participant including, without limitation, the Released Parties.

____ (c) In consideration of my participation in the Festival, I hereby acknowledge and agree that I am a knowing, willful and willing participant, that this Agreement may be sued by the Released Parties, and any of their respective directors, officers, employees or agents, as well as by the venues and event sponsors or organizers, in any action arising from activities related to Festival events in which I participate, with this
Release of Liability, Waiver and Indemnity Agreement.

____ (d) I HAVE CAREFULLY READ THIS AGREEMENT AND FULLY UNDERSTAND ITS CONTENTS. I AM AWARE THAT THIS FORM IS A WAIVER, RELEASE OF LIABILITY AND INDEMNITY AGREEMENT AND A LEGALLY BINDING CONTRACT WHICH I AM SIGNING OF MY OWN FREE WILL.

____ (e) I understand and agree that the Released Parties may NOT be held liable or responsible in any way to me or my family, heirs, successors, assigns, or anyone claiming any interest through me, for any injury, death, or other damage that may occur as a result of my participation on the Festival or as a result of the negligence of any participant or party, including, but not limited to, the Released Parties.

____ (f) By signing this document, it is my intent to release, waive, hold harmless and indemnify all of the Released Parties from all liability, claims or causes of action connected with my participation in the Festival, and to personally assume all risk of injury or death. I UNDERSTAND THAT THE TERMS OF THIS DOCUMENT ARE CONTRACTUAL AND NOT A MERE RECITAL AND UNDERSTAND THAT I WOULD NOT BE PERMITTED TO PARTICIPATE IN THE FESTIVAL WITHOUT ENTERING INTO THIS AGREEMENT. I HAVE SIGNED THIS DOCUMENT VOLUNTARILY AND OF MY OWN FREE WILL.

Model/Photograph Release

____ 5. I understand that my participation in the Festival may be photographed and promoted by the Troost Festival, or any other organization or individual involved with the creation or promotion of the Festival, and in consideration for permission to participate in the Festival, I hereby give permission to the Released Parties to use my likeness for any purpose whatsoever. I RELEASE TROOST FESTIVAL AND ANY PHOTOGRAPHERS, THEIR OFFICER, EMPLOYEES, AGENTS, AND DESIGNEES FROM LIABILITY FOR ANY VIOLATION OF ANY PERSONAL OR PROPRIETARY RIGHT I MAY HAVE IN CONNECTION WITH SUCH USE.

Severability

____ 6. If any provision of the document is held to be invalid or unenforceable, in whole or in part, by any court of competent jurisdiction, such provision shall be deemed amended to conform to the requirements of law, so as to be valid and enforceable. Or if it cannot be amended without materially altering the intention of the parties, it shall be stricken and the remainder of this Agreement shall remain in full force and effect. It is the intent and purpose of the Agreement to provide the broadest possible release of claims and causes of action in favor of the Released Parties, and any ambiguity shall be construed in light of this purpose.

Miscellaneous:

____ 7. I have read and understand this Agreement and I am voluntarily signing this Agreement on behalf of myself and my heirs. I understand that by signing this Agreement I am waiving important legal rights on my behalf and on behalf of my family and heirs. I expressly acknowledge that I have had the opportunity to consult with legal counsel before signing this Agreement.

____ 8. I hereby consent to any hospital care or medical or surgical diagnosis or treatment which may be necessary as a result of my participation in the Festival. I am solely responsible for all applicable charges for any such medical diagnosis or treatment, and represent that I either have insurance coverage adequate to cover such expenses or am financially capable of paying for such expenses. If I become incapacitated and am unable to give consent for medical treatment, I hereby grant all appropriate medical personnel permission to perform any medical treatment they deem appropriate.

____ 9. This document shall be governed by and interpreted under the laws of the State of Missouri, without regard to conflict of law provisions. If any lawsuit or claim is brought arising from my participation in the Festival, I agree that the exclusive jurisdiction and venue for such suit shall be the Jackson County District Court in and for the State of Missouri, and I hereby irrevocably waive any other jurisdiction or venue to which I or my estate might otherwise be entitled.
